Call to Order

Distributed Energy Resources (DER) Rules, Policy, and Rate Schedules

Engineer Kristi Robinson of STAR Energy Services LLC joined the meeting via Zoom for a discussion on recommended changes to the DER rules, policy, and rate schedules.

A motion was made, seconded, and carried to make the recommended changes to the "Cooperative Cogeneration Rules Implementing 216B.164", Board Policy 4-20 "Cogeneration/Distributed Energy Resources", Rate Schedule 18 "Distributed Generation (DG)" (to be renamed "Distributed Generation 40 kW and Greater") and "2021 Cogeneration and Small Production Supplemental Schedule" (to be renamed Rate Schedule 20 "Distributed Generation Less Than 40 kW"). Rate Schedule 20 "Distributed Generation – General Service," Rate Schedule 21 "Distributed Generation – Multi-Phase Service," and Rate Schedule 22 "Distributed Generation – Large Power Service" were to be voided and no longer rate schedules.

Annual Cogeneration Report

After discussion, a motion was made, seconded, and carried to accept the 2020 Annual Cogeneration Report.
